Should a formal complaint be received about the conduct of any member of the club in terms of the above they may be asked to appear before the disciplinary committee of the club.

The member in question will be notified to appear before the disciplinary committee of the club via the contact information provided on the membership form or alternate contact details as provided in writing to the club by the member. The decision of the club disciplinary committee will be final and binding upon the member.
